

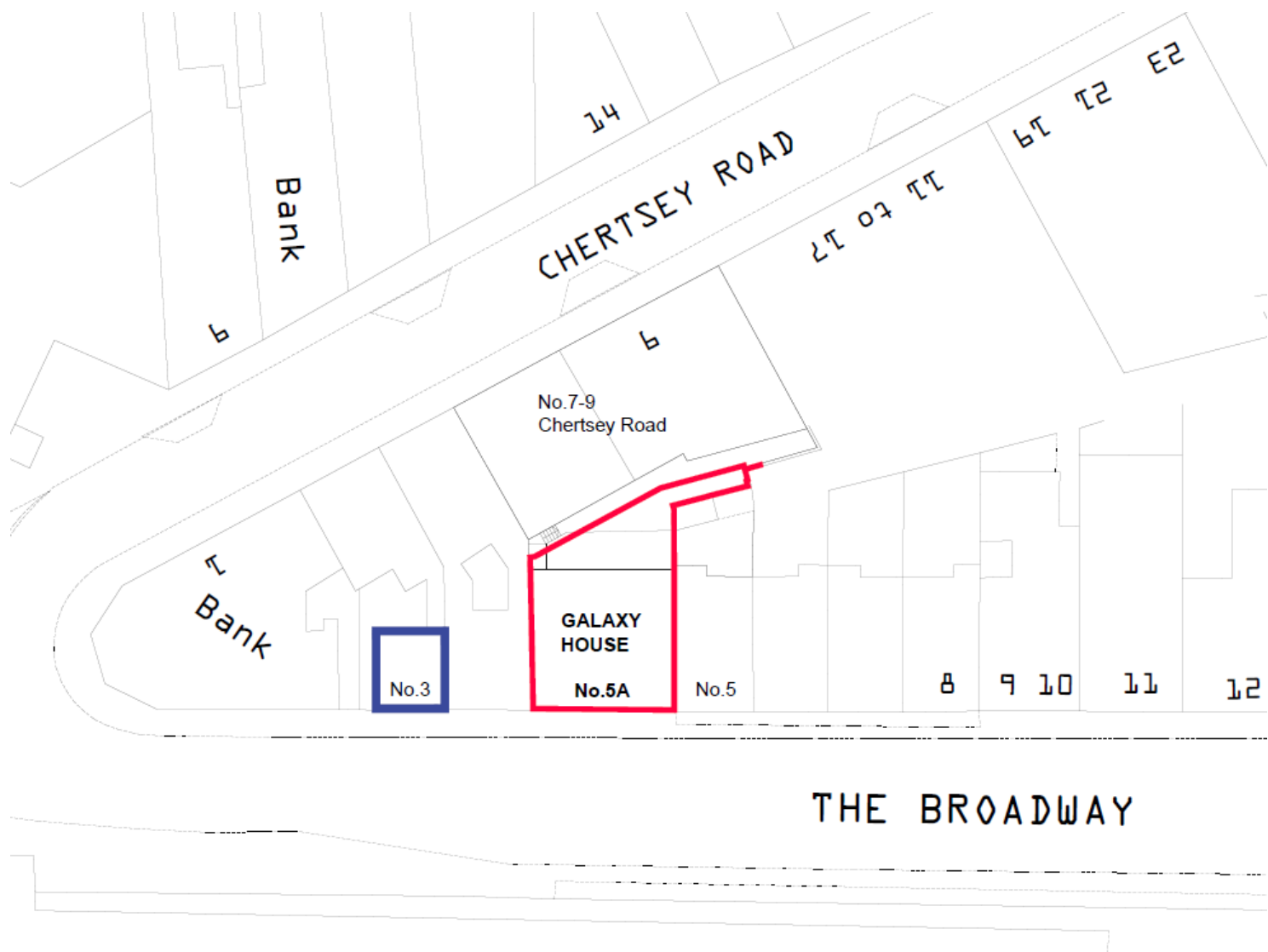

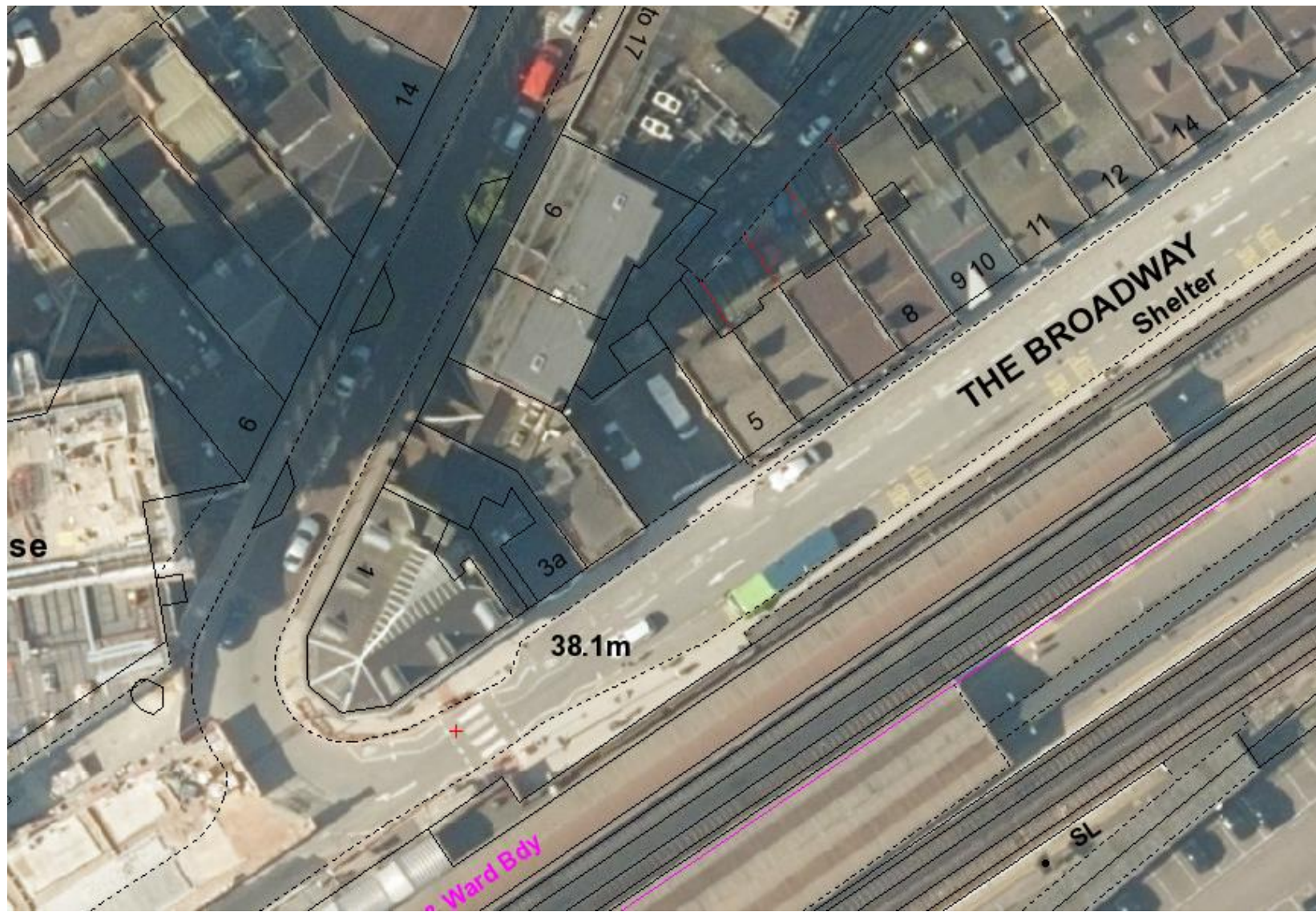
5A The Broadway, Woking

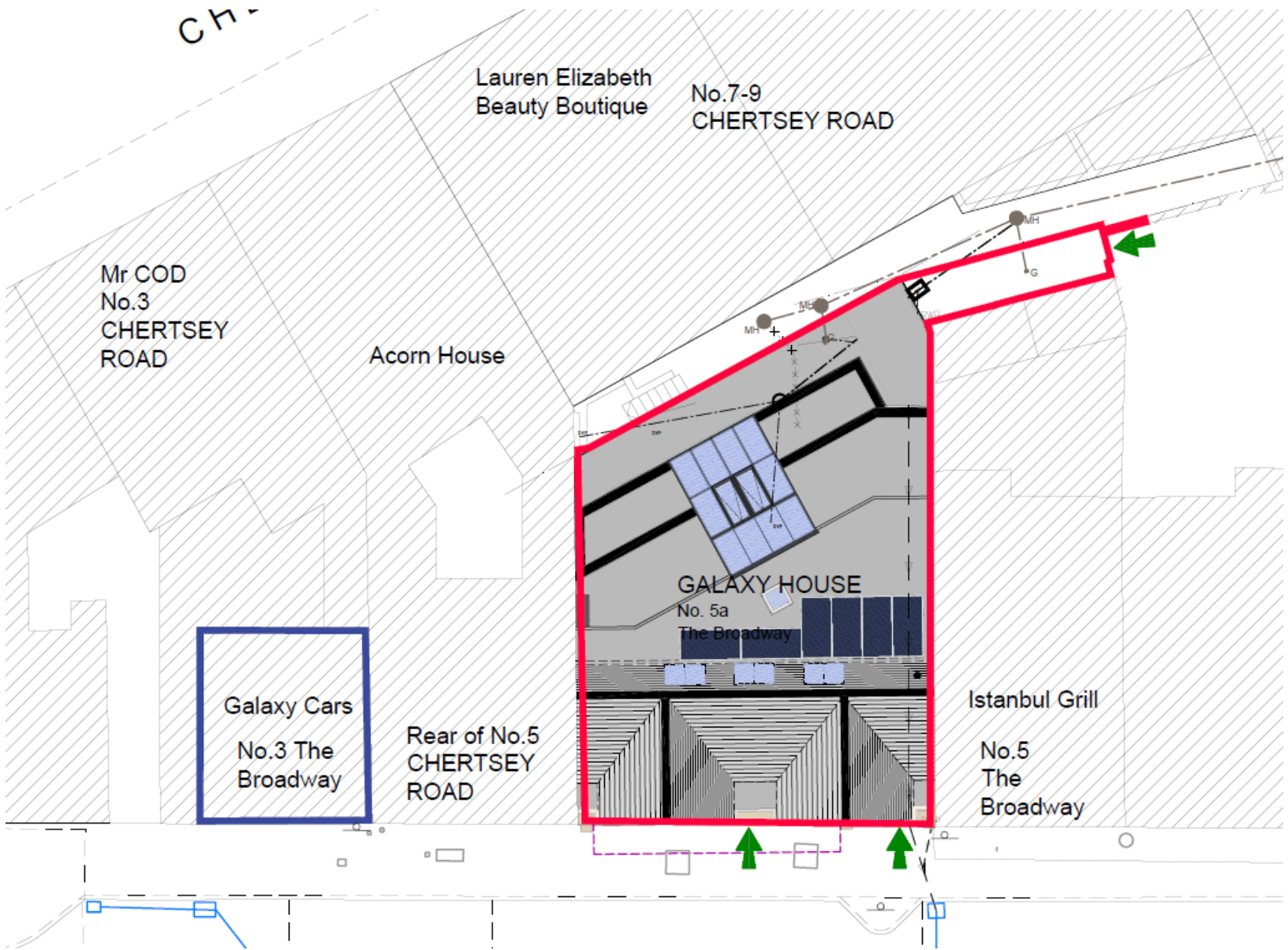

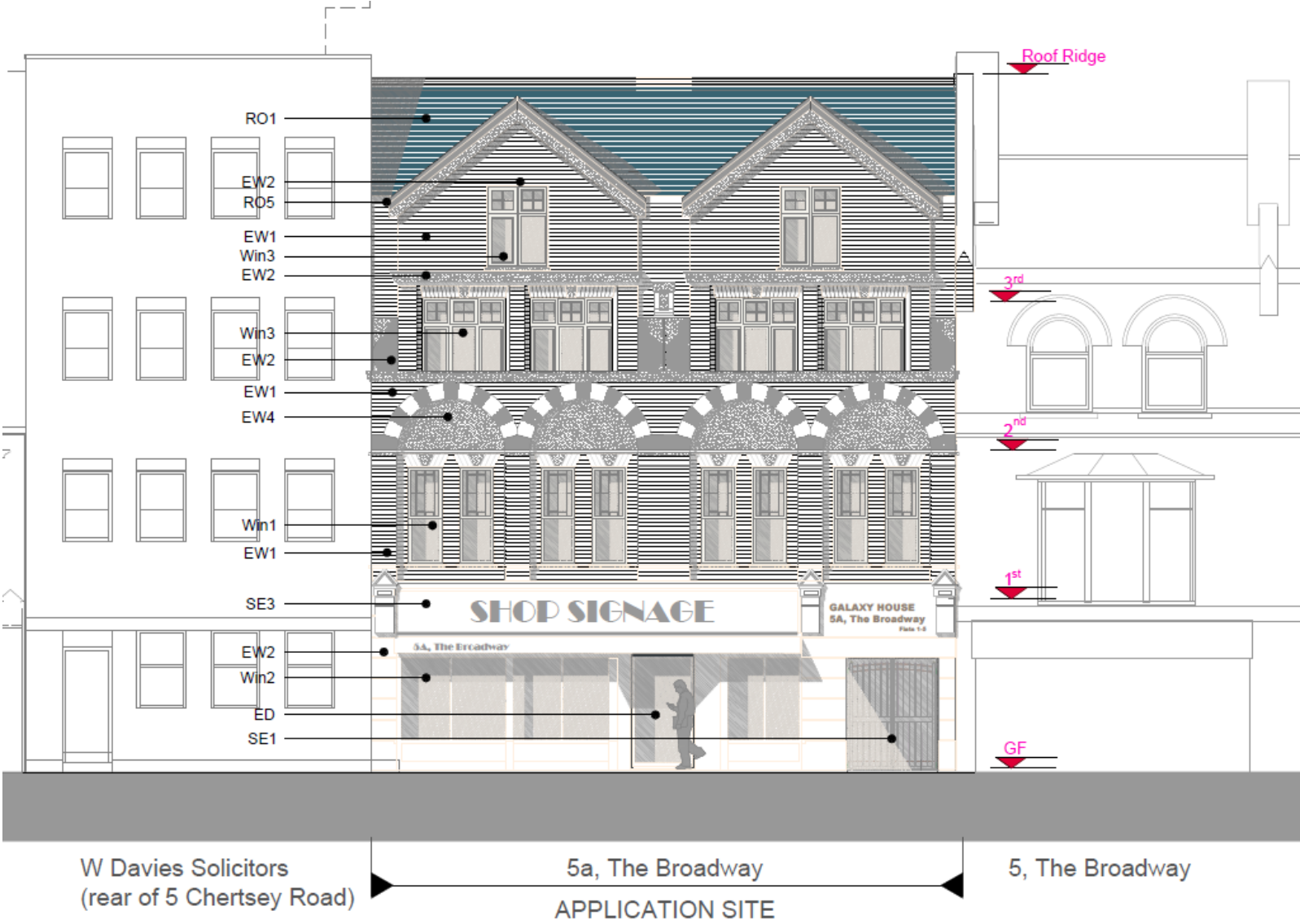

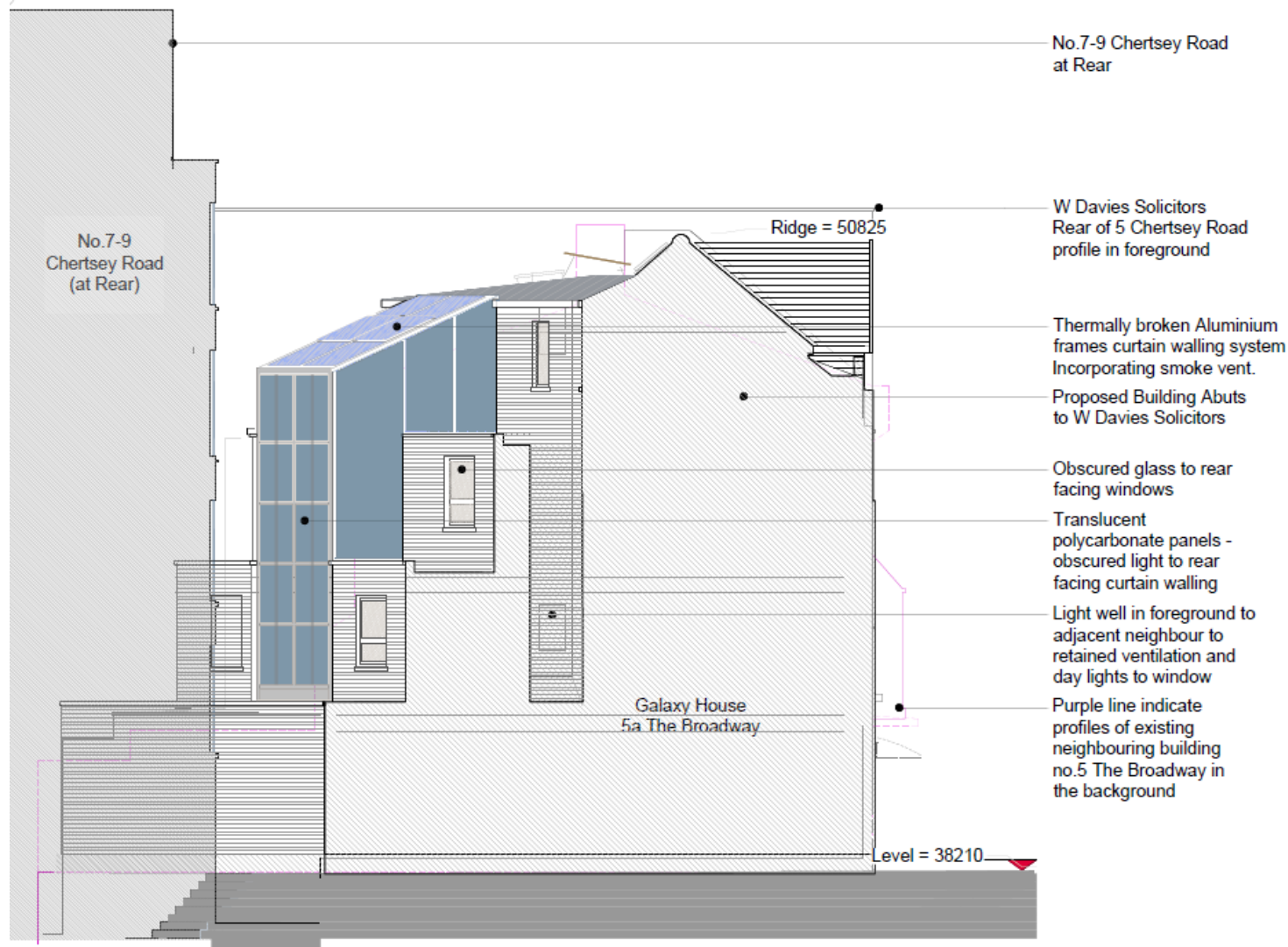

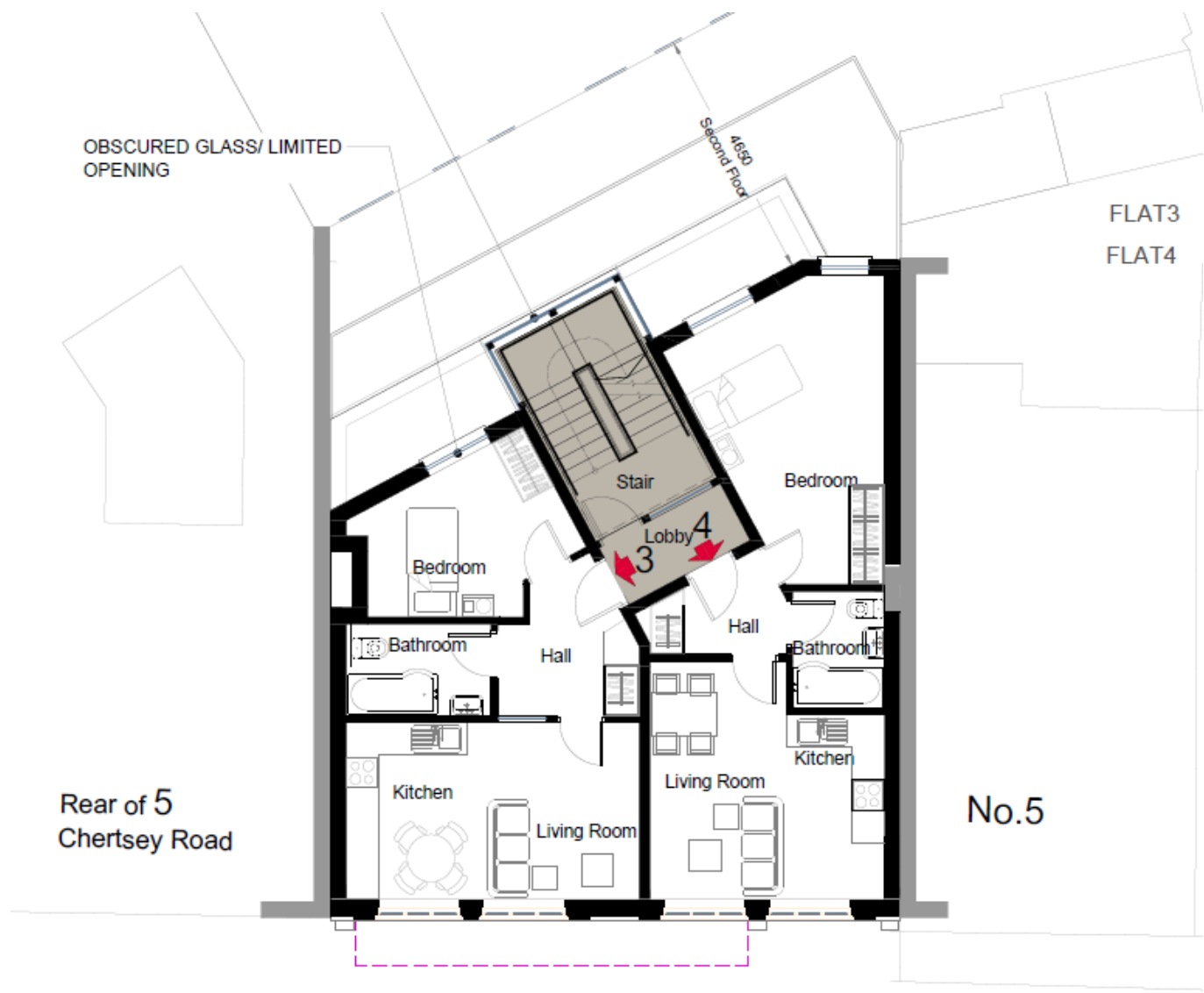

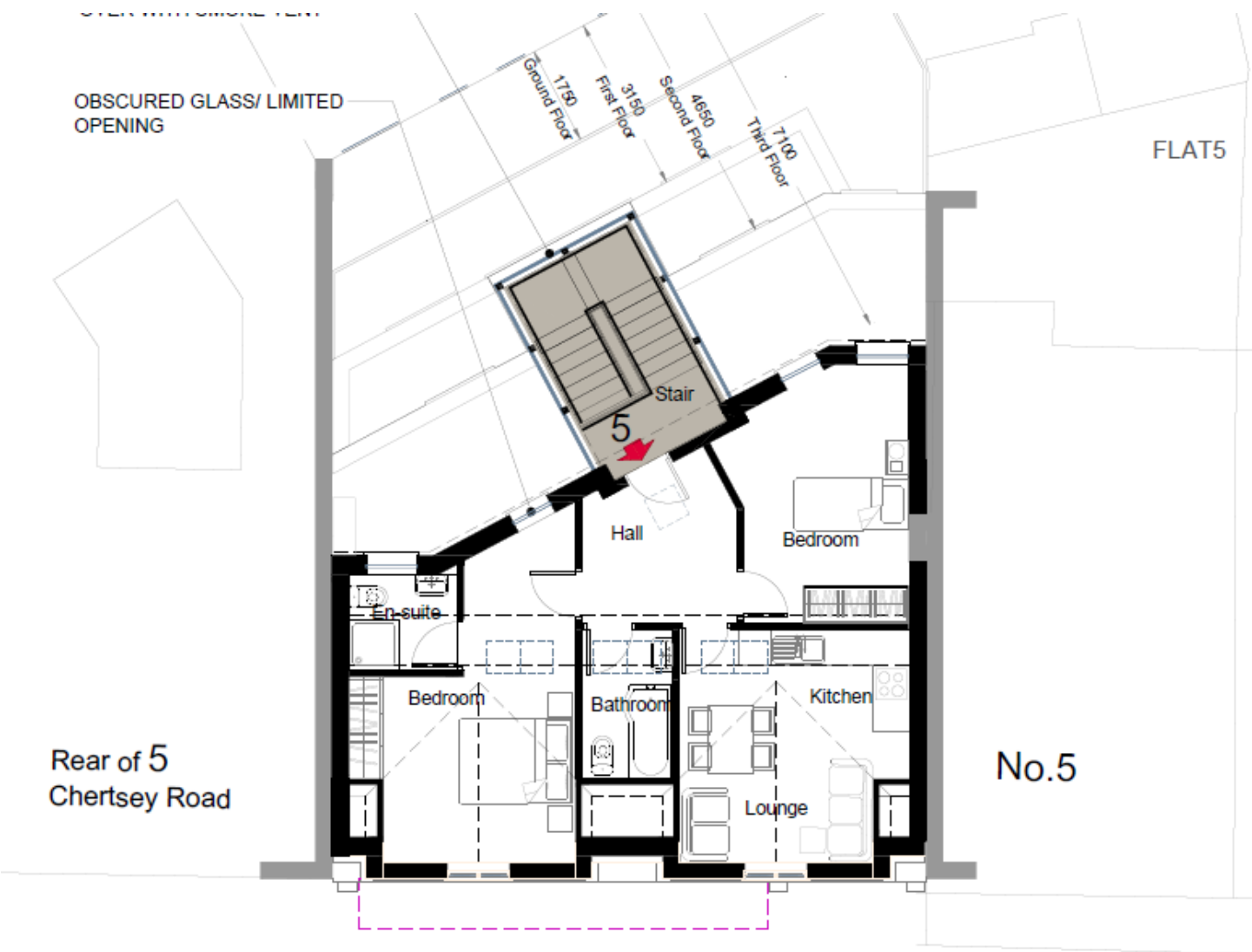

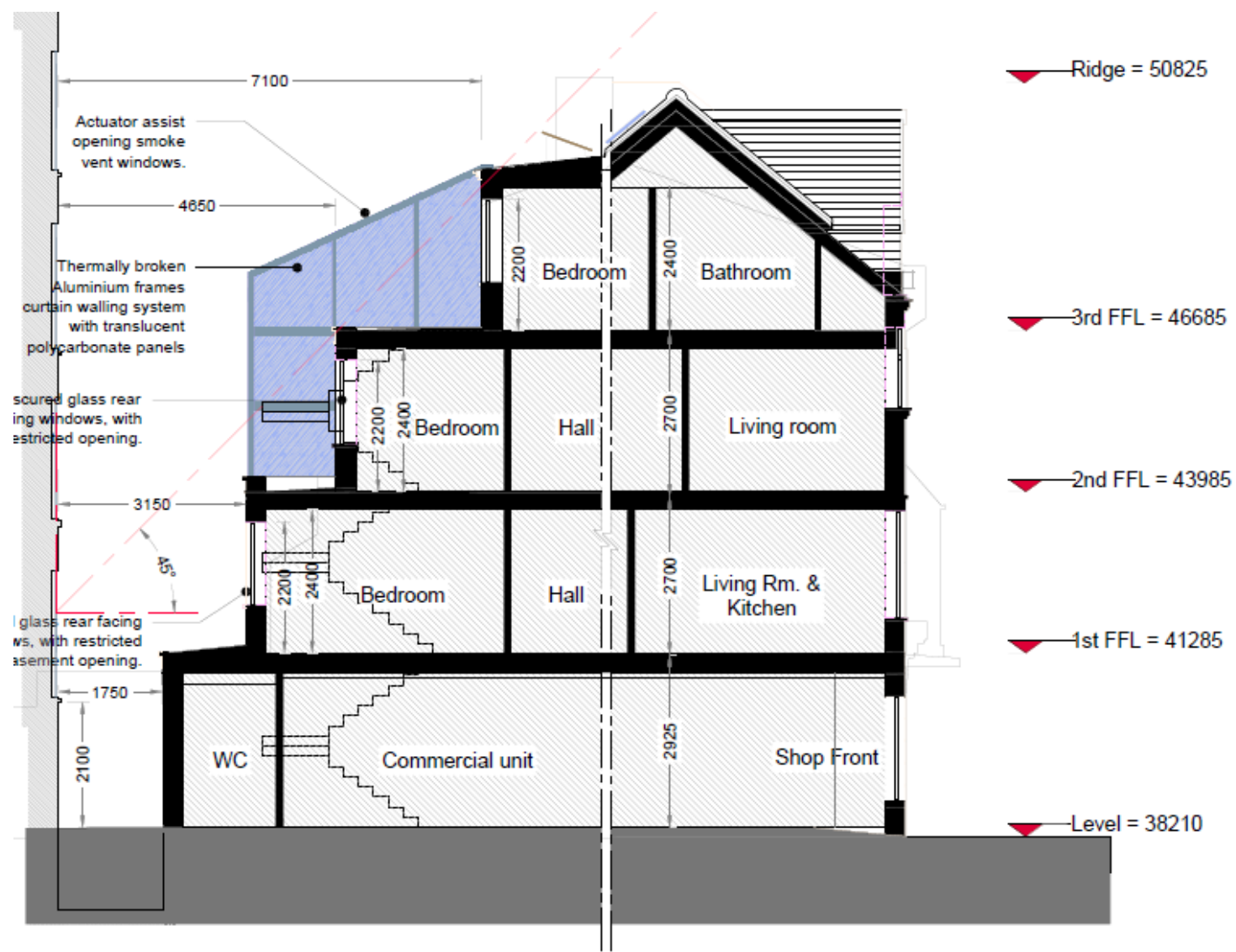
