

**Delegated Authority
Elderly People's Lunch Club Grant Awards 2021/22**

A number of discretionary grant schemes are available through the Council, aimed at assisting a variety of organisations and individuals through grant funding, one of which is the Elderly People's Lunch Club Grants Scheme. Each year, Elderly People's Lunch Clubs are invited to apply for financial assistance to aid with their running costs. The level of grant awarded is based on the number of members of the Club over the age of 60. The scheme is administered by Democratic Services.


The criteria for applications are as follows:

- Grants will be made to Voluntary Clubs established mainly for the purpose of providing meals and/or recreation for elderly people. The grant must be used for this purpose.
- Elderly people are defined as persons over the age of sixty.
- Clubs shall keep accounts sufficient to show that any grant received from the Council has been spent for its intended purposes.
- Clubs may be required to submit their membership records and accounts for scrutiny before the grant is paid.
- Grants will not be paid to clubs having less than twelve members over the age of sixty.

Three Clubs have applied for a grant in the 2021/22 financial year. Elderly Peoples Lunch Club Grant Awards are funded through the main Grants budget under delegated authority. The delegated authority is under the Chief Executive's ostensible authority. Attached is the schedule of applications for 2021/22 with a total amount claimed of **£351.00**.

RECOMMENDED that the grants as set out in the attached report be awarded.


